On November 15, 1978 we were incorporated and registered with the BC Societies Act as an official non-profit Society.

Thank you to those founding members!

Today, we are thrilled to include Dr. Bruce Tobin and Dr. Kathleen Collis here at this AGM and conference.

In <u>1989</u> the Purposes of the Society were registered with the Society Act – now known as our Constitution.

Then in 1994 we obtained Occupational Title Protection with the Society Act for "BCATR" – "British Columbia Art Therapist, Registered". On page 2 of this handout you will see a chart presenting the membership and financial trends over the last 25 years.

- In 1980 the association had 9 voting, and 7 non-voting members (total of 16)
- Our membership peak occurred in 2001 with 112 voting, and 55 non-voting (total of 167)
- As of June 16, 2004 we have 96 voting and 27 non-voting (total of 123)

volunteered themselves to form your Executive while recognizing the value of this association. I am very proud of what this incredible team has accomplished in a year – and below is a list of the highlights:


#### **Achievements:**


- we formed a cohesive and professional team

- September I attended the BC Therapeutic Recreation Association's Annual Conference to market art therapy
- •October I composed the Interim Newsletter e-mail
- discussions with the BC Association of Clinical Counselors Executive VP to learn about a mandatory ethics workshop that they will institute in the coming year (goal to teach 'members a practical decision-making process that is the key to accountable professional practice,' in addition to including an

assimilated investigation.)

# Ethics: Dr. Kathleen Collis, PhD, ATR, BCATR

Summary Report on the work of the Ethics Committee (June 03-Feb 04)

Ethics Chair Monica Carpendale, B.F.A., DVATI, RCAT, BCATR resigned on Feb. 3, 2004 as Ethics Chair, after completing the open ethics files.

The Ethics Committee focused on responding to and processing six complaints. The complaints were handled with a few letters and phone calls. One complaint took over six months to complete due to delays of the respondent.

The complaints pertained to issues concerning.

- 1. Professionals providing art therapy who are not trained as art therapists.
- 2. Client complaints against art therapists as service providers.
- 3. Professional respect between art therapists.
  - 4. Discussions with reference to a

clear definition of the role that the ethics committee holds within the BCATA Executive.

Ethics Report to June 19, 2004

Kay Collis, PhD, ATR, BCATR agreed to continue as Ethics Chair to the AGM June 19th, 2004

There have been no complaints or concerns forwarded to her during that period.

# Recording Sec: Gabrielle Cordella-Chew, MPS, ATR, CCC

Last year, a number of BCATA Executive volunteer positions needed filling in order for the Association to continue to exist. I volunteered to fill this position, and was appointed.

As Recording Secretary my primary responsibility has been to record the minutes of each Executive meeting, collect and integrate Executive Members' reports, and distribute these complete minutes to the Executive via email.

As a full-time clinician and practicing artist, I am unable to donate my time to our Association for a second year. As this volunteer position ideally encompasses a two- year term, there is now an opening for interim Recording Secretary for 2004-2005.




### Comments on the financial reports:

# Membership: Michelle Gilligan, MA

In November I took over the position from Liina. She had processed the numerous overdue renewals (more than a third of the members renewed after the AGM last year). She had also begun the process of going through all of the membership files to ensure that the membership set and the administration (back-up) set are complete and contain the same information. Thank you! • The membership packages were sent out to current and former members at the beginning of March. • As of June 16 we currently have 123 members -97 are renewals and 26 are new **members**, which breaks down into the following categories:

Registered Professionals - 47 Professional Members - 44 Associate Members - 4 Student Members - 23 Honorary Life Members - 5

# This represents 96 voting and 27 non-voting members.

Thank you to all the members who renewed on time this year. As in previous years, any members who do not renew by June 30th are removed from the active mailing list, and notification is sent to our insurance provider, the Mitchell and Abbott Group. Only current members are eligible for coverage.

### Recommendation:

• add a membership category for retired members (intended to encourage those members who have retired from practice to continue to be a part of the association, and to maintain insurance coverage, at reduced rates)

# <u>Initiatives for the coming year</u> include:

• create membership database on the website that can be easily searched by members of the public who are looking for an art therapist.

- create the "Honours Procedural Manual" that will guide the process of nominating and awarding honorary life memberships
- continue to increase membership and respond promptly to questions and requests from members and the public.
- creation of a manual to assist the new Membership Chair for 2005

The most rewarding aspect of this position has been the opportunity to get to know the BCATA membership. I have now learned at least the names of all the members, and have had the chance to know many of you, and especially the executive, on a more personal level. It has been a pleasure working with everyone, and has helped me to feel more connected to the vibrant and growing community of art therapists in B.C.

# Registration: Margo Farr, BA, Dip AT, BCATR

The Registration committee currently consists of 4 members – Adaline O'Gorman, Linda Lange, Lisa Bernstein, and me (Margo Farr). Registration Chair is a 2-year term. As Chair, I have held this position for 2 1/2 years.

The committee meets in Victoria, 3 times yearly to review applications for registration. In the past year we have accepted 7 professional BCATA members for Registration, plus one application pending.

During this past year we have made several adjustments to the application package for clarification so that it is more "user-friendly". There are no specific guidelines in the by-laws regarding face to face versus telephone supervision. Currently we have been advised by the Executive to accept a maximum of 50% telephone supervision, requiring at least 50% face to face. This unfinished piece of business carries over to the new Chair to amend the by-law for voting at next year's AGM.

As my term is now over I thank the current Executive for the teamwork and determination that everyone has shown over the past year. These 2 1/2 years have been an interesting learning curve for me, and I exit with best wishes for the new Executive team and for the Association.

## Administration/ Bookeeping/Web: Merle Schwartz

I have spend this past financial year updating the BCATA website, emailing members and updating the Directory.

I have deposited all incoming monies and paid all the bills and reimbursed expenses.

I balanced the books monthly and send reports to the Executive as well as completing the year-end Financials.



# College of Counselling Therapists Representatives: Michelle Oucharek-Deo, BFA, BCATR, RCAT

Summary of the events 2003-04

- •June -August 2003 no new developments with the College. At that point things were stayed in the parliament and our request was being tabled by the Minister present at that time.
- •December of 2003 members received confirmation that the MCFD Ministry had committed in writing that the proposed College of Counselling Therapist would be able to be designated under the Health Professions Act and not under the Social Workers Act. This step allowed the Task Force to move forward and begin having meetings to establish what needed to be done to meet the government requirements in

forming this College.

- · February there was a cabinet shuffle
- April 26<sup>th</sup> meeting: Dr. Cane attended (who develops competency profiling in projects such as these). It was decided that Dr. Cane would be retained to give a workshop that would better explain how the profiling would help us in our pursuit.
- May 17th Seminar with Dr.Cane. Task Force decision was made to hire Dr. Cane to begin first level of competency profiling

#### **Recommendations:**

Approve Funding for College Development Costs as follows:

- 1. April 26th 2004 Meeting (per group cost 8 groups) \$207.04
- 2. May 17th 2004 Meeting (per group cost 8 groups) \$578.34. For a total of \$758.38
- 3. Level 1 Competency Profiling \$1500.00-\$2000.00
- 4. Initiate Fundraising Ideas
